#### 2. Breach of confidentiality

There has been a serious breach of the code of conduct, with confidential matters discussed at a council meeting being distributed to members of the public. This is despite members being reminded by the Mayor that the proceedings should be kept confidential.

This breach is likely to have serious financial implications for the Council and as a result, the taxpayers of Sandy. It is my duty therefore to draw members' attention to the following:

"Individual members and officers of local authorities are not generally liable for the authority's acts or omissions. Section 265 of the Public Health Act 1875 provides councillors and local authority officers, when acting in the course of their duties and in good faith, with statutory immunity for the actions they take."

#### However:

"If the wilful misconduct of a councillor is found to have caused loss to a local authority, the councillor may be held liable to make good such loss to the council (section 161(4) of the Local Government Act 1972)."

"Where the local authority is found to be vicariously liable for the acts or omissions of an employee or member, the authority arguably has a duty to pursue a contribution from that employee or member."

Obviously it is too early to consider the possible implications of the present situation but it may well be something members need to consider in the future and they need to be aware that their office does not convey complete immunity for their behaviour upon them.
