3 Re-organisation of Committee Structure

At present there are 3 committees which each have ten members giving each councillor two places on these bodies. The other main group is the Human Resources Committee which has full committee status but is not included in the current set up.

It is clear that some members would like all members to sit on each of the 3 main committees. However this is not legal as they would have to be chaired by the Mayor. This is not considered desirable as it would prevent other members from getting experience of chairing a committee and contributing to the organisation of the Council.

Any changes in membership of committees would have to be a multiple of 15 if all councillors were to have equal opportunities to contribute to the decision making process of the Council.

A possible organisation could be:

Councillors who are not members of any committee may still attend and speak but cannot propose resolutions or vote.

Substitutes

It is also proposed that councillors who are not members of a committee would be eligible to be a substitute for that panel. Members who know in advance that they will be unable to attend and can give their apologies can ask another member to substitute for them.

If a member is prevented from attending at short notice and there are noncommittee members present at the meeting then one or more of them can substitute for absent members. This could be on a casual or a formal basis where the committee votes to approve a substitution.

Other Commitments

It is recognised that some members with other commitments may not wish to serve on 3 committees in addition to full Council. The average attendance would be 4 Monday nights in any one six week period. This would leave vacancies on a committee which would be filled by other willing members being proposed and seconded at the Council meeting where places on committees are decided.

Councillor Preferences

Prior to the meeting where places are to be allocated each member would complete a form giving their preferred options up to the maximum of 4 places.
