Purpose of the Report

1. To provide Members with information regarding a call to action from the Society for Local Council Clerks (SLCC) following the Government's published response to the Committee on Standards in Public Life (CSPL) review.

Recommendation

- 2. That the Council notes the report.
- 3. That the Council writes to their MP asking that he back an Early Day Motion calling for the Government to establish an appropriate and effective sanctions mechanism to deal with local councillors who have been found guilty of bullying and harassment following an independent investigation.

Background

- 4.0 On 18 March 2022, the Government <u>published its response</u> to the <u>Committee on Standards in Public Life (CSPL) review</u> and recommendations on local government ethical standards. SLCC's Chair of the Board, Steve Trice, expressed his disappointment to this response in an SLCC <u>news bulletin on 22 March 2022</u>.
- 4.1 Despite the disappointment of the Government's response, SLCC is continuing to campaign in this area and has sent a request to Clerks and Councils asking them to try to raise this issue in parliament.
- 4.2 Dr Julian Lewis, MP for New Forest East, has tabled an Early Day Motion (EDM) which calls for the Government to establish an appropriate and effective sanctions mechanism to deal with local councillors who have been found guilty of bullying and harassment following an independent investigation.

Information

5.0 What are EDMs?

EDMs are motions submitted for debate in the House of Commons for which no day has been fixed. Whilst few are debated, many attract a great deal of public interest and media coverage.

- 5.1 They are used to put on record the views of individual MPs or to draw attention to specific events or campaigns. By attracting the signatures of other MPs, they can be used to demonstrate the level of parliamentary support for a particular cause or point of view.
- 5.2 The more MPs that support this EDM, the more likely it is to get discussed in parliament.

Model letter for councils to local MP



Dear (name of local MIP).

On behalf of (name of town or parish council), I am writing to ask for your help in addressing concerns about the bullying, harassment and intimidation of local town and parish councillors and their staff, all working in and for their communities. It echoes the growing malaise around the safety of our MPs whose day to day work is made more difficult through incivility, online and in person abuse, stalking and even threats which sometimes reach families and constituency staff. Public servants, whether working nationally or locally, deserve protection from this.

At local level, this is an issue with a significant impact. It is partly reflected in the low numbers of candidates, particularly females, stepping forward as local councillors, uncontested elections and, in some cases, a reluctance to take on public facing work (for fear of abuse (e.g., attendance at councillor surgeries and meetings). With more than 10,000 town, parish and community councils (plus 735 in Wales) and with around 100,000 councillors, this worsening situation is magnified and clearly bad for democracy.

In the last 2 years, the high turnover of professional clerks, (a clerk is the executive officer steering the council and usually its responsible finance officer) is now heading towards a major recruitment and retention issue. Some clerks are experiencing not only casual abuse from the public as they run their councils but, sadly, in some documented cases, persistent incivility from the councillors they serve. Unlike most other employees, clerks have no recourse to this unacceptable behaviour and often, with little in the way of sanctions, the only option is for a clerk to resign.

The National Association of Local Councils (NALC), One Voice Wales (OVC) and County Associations representing local councils and councilors in England and Wales as well as the Society of Local Council Clerks (SLCC), the professional body for clerks, have together recognised this. Investment has been made in a Civility & Respect Project which is coordinating a programme to support councillors and staff within our sector via training, good governance, clear policies and intervention processes. It will also work to influence relevant legislation to combat online abuse, introduce sanctions and enhance the role of monitoring officers.

It is work sitting alongside that already being taken forward by the Local Government Association (LGA) to promote civility in public life for councillors and staff working for principal councils. It also ties in with recommendations set out in 2019 Local Government Ethical Standards Report issued by the Committee on Standards in Public Life.

Name of council would welcome your support and that of your fellow MPs in raising this important national issue via parliament.

Vandalism at Bedford Road Recreation Ground

Purpose of the Report

1. To provide Members with information regarding a spate of recent vandalism at Bedford Road Recreation Ground.

Recommendation

2. That the Council notes the report.

Background

- 3.0 On Tues 15th March the outdoor team had to remove a section of play equipment (toddlers train) from Bedford Road Recreation Ground after vandals had pulled the equipment from its fixings and broken the structure.
- 3.1 On Friday 18th March, further damage was sustained to the remaining parts of the train which the outdoor team discovered and tended to on the Monday morning to make the area safe.
- 3.2 On Friday 25th March the outdoor team reported that a picnic table in the area had also been vandalised, jumped on and an attempt to set light to the table was evident.
- 3.3 The Outdoor Team Leader has also reported that on most nights, particularly as the weather has been improving, there have been motorbikes being driven within in the park, young people in the park from about midnight, smells of cannabis being smoked and general anti-social behaviour. The outdoor team are working hard to make and keep all our equipment safe, and clear up any debris, on a daily basis.

Information

- 4.0 On attempting to access any CCTV footage of the incidents, it was discovered that the electrical supply to the cameras had failed. ADT have been contacted and were due to attend site on 6th April 2022.
- 4.1 Reports have been made to the Police (crime ref reference 40/17105/22 for the criminal damage and arson) and the Safer Central Bedfordshire Team. Both the local policing team and Safer Central Teams confirmed that extra patrols had been undertaken in the area and that no sign of further vandalism or antisocial behaviour had been reported/witnessed. Unfortunately, a lack of CCTV evidence means that any further investigation of the incidents will not take place at this stage.
- 4.2 A log has been created, under reference bp-26032022-0136 and sent to Bedfordshire Police's Anti-Social Behaviour team to review.
- 4.3 The Clerk is working with ADT to get the CCTV service up and running asap.
