Members were advised by Cllr Aldis that Kings Road Surgery site has been extended following the acquisition of the bungalow next door and the RSPB application for the wind turbine is on hold as Cambridge Airport has reported to Central Bedfordshire Council that the movement of the blades could lead to flickering on the radar system.
