### **Background**


- **3.0** As part of the Trees for Climate programme The Forest of Marston Vale are working with Central Bedfordshire Council to create a new 30ha community woodland north of Beeston on former arable fields between the A603 and Vinegar Hill as shown on the attached location map. The new woodland will be planted with both native broadleaf and conifer trees as well as native shrubs. The woodland will also include an area to be set aside as community allotments and accommodate a section of the Sandy Greenwheel.
- **3.1** The Forest of Marston Vale and CBC are seeking comments regarding the proposed woodland by the 1<sup>st</sup> December 2022. All comments received will be sent to the Forestry Commission as part of the Environmental Impact Assessment. The leaflet attached provides further details on the Trees for Climate project.

### **Financial Implications**

4.0 At this stage financial implications are not clear, if allotment land were to be made available then negotiations around rent and the costs for maintenance would need to be discussed and allowance made in the appropriate budget.

#### **Legal Powers**

**5.0** Under the Smallholdings and Allotment Acts 1908 ss 23,26 & 42 parish councils have a duty to try to satisfy demand for allotments.




